## Rules and conditions of entry 2010

1. Competitors must be experienced and accomplished riders with appropriately trained and fit horses capable of undertaking the conditions of all 5 phases of the event.
2. A rider may compete on more than one horse as long as no other competitor is riding the same horse during the competition at any level.
3. Competitors may enter more than one horse- if entries are exceedingly high, a restriction may apply, each additional horse will be charged full entry fee.
4. Riders competing in the junior section must be minimum of 10 years old on the day – and not more than 16 years old at the start of the competition.
5. Competitors choosing to enter the encourage section are not eligible for the open event & vice versa. Entries in this section will be at the discretion of the committee.
6. Highpoint Lady and Gent Veteran rider – all riders over 50 years will be automatically entered.
7. High Point Registered Horse Awards. Horses must be nominated at time of entry. A copy of the horse's full registration papers and a copy of the rider's current membership to the appropriate association/ Society must accompany the entry form.
8. Riders must nominate at time of entry for the high point Local Junior, Lady or Gent (Postcode within 100km's of Mundulla)
9. Team event – All Open competitors will automatically be entered in the Team Event.
10. The expected dress code must be worn for the entire program and will be comprised of:
  - a. Collared shirt with sleeves
  - b. Approved safety Helmet and footwear must be worn for all events
  - c. Jeans or jodhpurs will be accepted
11. Any horse considered to be acting in a dangerous manner will be warned by the committee in the first instance and then disqualified if it continues to act in a dangerous manner.
12. Stallions must be ridden and handled by an adult (over 18 yrs) and tie dup with both halter and neck strap (doubled tied)
13. Snaffle bits only to be used – no curb chains.
14. Horses must wear a bit, no bosals or halters will be allowed
15. No head checks, tie downs, martingales, running reins, nose bands or riding whips will be allowed.
16. The same saddlery must be used for the entire five sections of the event, leg protection for horses at rider discretion.
17. Competitors must complete the program as set by the committee.
18. No alcohol to be consumed whilst competing or prior to completion of the day's events.
19. No unrestrained dogs allowed.
20. All competitors enter at their own risk with no responsibility accepted by the organizing committee for riders, livestock or property.
21. **All decisions made by the judge are final.**
22. In the event of a protest: it must be lodged within ½ hour of the event with a \$20 non- refundable deposit. The protests committee will be the judge, horse convenor of the Mundulla AH&F Society and the Convenor of the Challenge.
23. All entries including full payment – cheques made to Mundulla AH&F Society – and horse registration papers etc. must be received by: February 19<sup>th</sup> 2010
